For employees terminating their employment with the Archdiocese of St. Louis, please see the following:

- If ending employment on or before June 30, 2022, you may give your former employee the attached materials, which includes the Health Insurance Plan's <u>Early Retiree Provision 2021-2022</u> and/or the <u>Continuation of Coverage Provision for 2021-2022</u>, along with the informative Handout for Benefit Terminations 2021-2022.
- If ending employment after July 1, 2022, please refer the former employee to the "Ending Employment" icon on the Benefits webpage, which includes all necessary forms/information for Early Retiree and Continuation of Coverage Provisions for 2022-2023.

For benefit eligible new hires after July 1, 2022, please refer to the "New Hire" icon on the Benefits webpage for all necessary benefits forms/information that needs to be provided to a new hire (Important note: federal guidelines require the Marketplace Coverage Notice to be handed out to all new hires so please be sure to do that). You may direct the new hire to our Archdiocese Benefits webpage (link in my signature line) for more detailed benefits summaries.
