Historical Note

Corporate Action for the Care of the Elderly (CACE) was a non-profit organization incorporated in 1976 by the Cardinal Ritter Institute and nine religious congregations in the St. Louis area, including Sisters of Charity of the Incarnate Word, Sisters of St. Joseph of Carondelet, Ursuline Sisters of the Roman Union, Daughters of Charity, Jesuits, School Sisters of Notre Dame, Sisters of Loreto, Sisters of the Most Precious Blood of O'Fallon, Franciscan Sisters of St. Mary. Later, the following co religious orders joined CACE: Vincentians, Alexian Brothers, Sisters of Mercy, Franciscan Sisters of Our Lady of Perpetual Help, and the Religious of the Sacred Heart.

In 1976, CACE realized that many people who contacted Cardinal Ritter Institute to request nursing home placement could not afford the market rate of such facilities. After several attempts to purchase existing facilities failed, the Archdiocese offered CACE ten acres of property on the Kenrick Seminary grounds for a skilled nursing home, which became Mary, Queen and Mother Center. CACE operated the management of the facility for the Board of Directors, which was responsible for both Mary, Queen and Mother Center and Our Lady of Life Apartments. It was determined that Mary, Queen and Mother Center would be open to all regardless of ability to pay.

In 1995, CACE turned over management of the nursing home to the Mary, Queen and Mother Center Association. From around 1997 to 2015, CACE dispersed funds annually in the form of grants to agencies and projects that addressed the needs of the poor elderly. On April 26, 2016, the CACE board met to approve a plan of voluntary dissolution by the end of the year.

Scope and Content

The records include the administrative materials of the organization, such as correspondence, meeting minutes, annual reports, bylaws and incorporation, year-end financial reviews and publications. Some of the documents are born digital. Upon accessioning, much of the materials were arranged chronologically in 3-ring binders by volume number. The original order was retained and the contents rehoused in folders with volume and date information.
