# **Importance of Blasts and PACT**

The PACT Newsletter and 'Blasts' are used to communicate important and timely information. Recently a parish staff member did not take the time to read a 'blast' alerting parishes to a recent scam and fell victim to that scam placing parish resources in jeopardy. We try our best to keep parishes well informed but the message only gets through if the communications are read. To be up-to-date on scams, due dates, important information, and tips on how to make your job easier; please read all Blasts and PACT Newsletters in a timely manner. If you have not received information from us in a



while, please check your spam folder for the Blasts or PACT. If someone in your office is not receiving PACT newsletters or Blasts, and should be, please update their contact information in PHOL..

# **Update Christmas Mass Times**

To ensure the faithful have the most up-to-date information please update your parish's Christmas Masses and Reconciliation times in Parish Helper OnLine (PHOL) and on your parish website. Updating PHOL enables the Archdiocesan website to display these schedules for each parish. Detailed instructions begin on page 6 of the User Manual which



schedules for each parish. Detailed instructions begin on page 6 of the User Manual which is located under the Help Menu in PHOL. The Start Date drop down menu lists the various Masses.—i.e. Christmas, Christmas Eve, etc.

#### **PPP Loan Forgiveness**

Parishes that have yet to receive PPP loan forgiveness are asked to contact their bank and inquire about the forgiveness deadline. While most banks are contacting their customers reminding them of the forgiveness deadline (which varies on each loan), we recommend you take the time to contact your lender and verify the deadline if you are unsure.

## **SLAF Holiday Hours**

SLAF is closing at noon on December 23rd. Hours for December 27th through January 3rd are 10am until 2pm, Monday through Friday.

# **Minimum Wage**

The state of Missouri is increasing the Minimum Wage from \$10.30 to \$11.15 an hour. The increase begins on January 1, 2022. Lawson will handle the update of minimum wages with the New Year. You do not need to send in PAF for those employees.



# **Mileage Rate**

According to the Internal Revenue Service, the standard mileage rate for business use of a personal automobile **increased** by 2.5 cents from 56 to 58.5 cents per mile beginning January 1, 2022. The IRS standard mileage rate is the maximum per mile reimbursement employers can offer their employees without reporting the amount as income.

# 1099-NEC Processing

Form 1099-NEC (not 1099-MISC) is used to report nonemployee compensation. Please review the 1099-NEC instructions to ensure compliance with the IRS regulations. Penalties for not filing correctly and providing all necessary information can be costly. As these forms help identify vendors that are 1099 eligible

## **Citrix Updates**

The IT Department will be doing System Upgrades on Tuesday-Wednesday (12-28 to 12-29) next week. The work will start around 10pm on Tuesday night, and we expect to have everything done by 6am, the next morning.

Here's a few things to look for, the next day:

If you're on an old version of Receiver or Workspace, you will likely need to upgrade to a newer version. The latest versions can always be found here:

Some of the nuisance issues that many of you have experienced in the past, such as window scaling issues (Ever tried to click on something in Citrix, and the cursor and mouse don't seem to line up?), should be gone.

One big thing to note: If you're running an extremely old PC, or one that has not had any updates on it, in the last few years, your experience will likely degrade. This is due to newer technology in the system that will be leveraged, that older systems simply don't support. (newer video codes, streaming tech, etc.)

#### Contact Lists in PHOL

It is important that parishes regularly update their staff assignments in Parish Helper Online. Make sure to include a cell phone number, for emergency text messages as we will test the system in January. Parish Support is most concerned with business manager, bookkeeper and parish secretary, but many other offices in the Curia communicate with other parish staff members. Please make sure all your parish assignments are up-to-date. Updates can be made in PHOL by going to the procedures tab, selecting location information, then the administrative tab. From there you may add the staff member's assignment and contact information.



#### **Contribution Statements**

The Archdiocesan policy regarding the distribution of annual donor statements is as follows: Parishes using ServantPC Cloud may place an announcement in their bulletin or mail postcards when the statements are ready for donors to download. Donors may also contact the parish office and request that a statement be mailed. If the parish is not using Servant PC Cloud, the policy regarding statements remains the same as in prior years: All statements are



mailed to donors (not emailed or placed in the back of church for pickup). If a donor notifies you that they have not received the mailed statement and requests a copy be emailed, you may do so. Annual Contribution Statements must be mailed or made available by January 31, 2022.

# **Servant Keeper Clean Up**

Parish Support has received several calls from parishes wanting to clean up their Servant Keeper files. While it is important to keep accurate records of who is no longer in the parish, in addition to legal requirements, it is important to remember that families labeled 'inactive' are still registered parishioners and deleting their information for the sake of 'cleaning the file' or cutting envelope costs is contrary to our mission.
