### **QB Upgrade Coming Soon**

Can you believe three years have passed since our last QB upgrade? We are currently using QB14 and will be upgrading to QB17 later this month. As with all upgrades, there are new capabilities and enhancements. The biggest change is increased password security. Upon conversion, your password must contain at least 7 characters, including I capital and I number. Due to this requirement, all Admin passwords must change during the conversion process. Most users will not be affected by the Admin password change and will easily be prompted to change their password to the new format at their first log-in. There are a few users that currently work using the Admin user to do their work. We are asking those users to create a new user so they will be able to log-in as that user after the conversion. The Admin log-in will no longer be available for day-today processing after the conversion.

The conversion is scheduled for the weekend of Feb.18-19. Access to QB will not be available all day Saturday and Sunday morning.



### **Basic Training Seminars**

Our February Basic Training seminar is cancelled due to the QB upgrade. The monthly seminar will return on March 22nd to the Cardinal Rigali Center with an improved format. The seminar targets new employees or anyone seeking to 'brush-up' their basic Servant Keeper, PHOL and QuickBooks skills. The training runs from 8:30am through 12:30pm. QB101 is for those seeking information on building reports, using the Find tool and various shortcuts and hints. QB102 focuses on entering transactions in QB. QB101 and 102 are offered from 8:30-10:30. Servant Keeper and PHOL basics complete the session from 10:40-12:30. You may attend one QB session (your choice) and/or the SK/PHOL session depending on your needs. Space is limited to 30 attendees.

Recently the Better Business Bureau (BBB) issued a scam alert about a phishing scam targeting small businesses.

Intended targets receive an email appearing to be from accounting software QuickBooks with the subject line "QuickBooks Support: Change Request." The fake message is confirming

a business name change with Quick-Books' manufacturer Intuit, but offers readers a link to cancel if the change is a mistake.

How do you post a check to RCF for an endowment?

Parishes wishing to donate to the Roman Catholic Foundation Endowment should post the transaction in the following manner. Write a check from your parish or school checking account payable to the Roman Catholic Foundation. The expense is posted to the 532100-Contribution expense account.

The endowment does not appear on the parish books as an asset. It is a simple expense that the parish has incurred.
