Status Animarum

The end of the fiscal year means that the parish Status Animarum is due. The due date is August 17, 2020.

To complete the Status Animarum you need the following five counts from your Servant Keeper file:

- 1. Number of Catholics
- 2. Number of Contributors
- 3. Number of Catholic households
- 4. Number of Mixed household
- 5. Total number of households

There should be existing Status Animarum groups in your Servant Keeper that will give you the needed numbers. If not, the Statistical Report Instructions are available on the Parish Support Website or by clicking on the button below:

This year it is **not** required to have members of the Parish Finance Committee sign the verification/reminders section. **Only the pastors signature is required**.

Status Animarum Reset

If you discover any errors on your baptism, confirmation or marriage registers after you have submitted your report, please contact Michele in Parish Support at 314.792.7072 to have your report reset so you may correct the errors and resubmit.

Annual Balance Review

Beginning August 17, all parish files undergo an Annual Balance Review. There is no need to notify Parish Support that your QuickBooks file is ready for Review. The QB file will be closed after the balance verification is complete.

Good news from Human Resources! UNUM is lowering the rate for disability insurance. Effective July 1, 2020 the rate drops from .242% to .2187%.

Parish Viability Grants

Pastors received a letter from the Archbishop with details pertaining to the Ensuring Parish Viability Endowment Grants. The EPV Fund provides grants in two areas, High Growth Grants and Stability Grants. Missionary Plan of Cooperation Appeals Cancelled

The Mission Office of the Archdiocese of St. Louis today announced that the 2020 Missionary Plan of Cooperation appeals in the Archdiocese of St. Louis will be canceled due to the suspension of public Masses and social distancing guidelines in the St. Louis area. The Mission Office has contacted all archdiocesan missionaries to notify them of this decision.

Every parish in the Archdiocese of St. Louis is invited to proceed with praying and coordinating a collection for their assigned mission group. The missionaries have been asked to send a written or digital version of their appeal, as well as photographs, to each parish for inclusion on parish websites, bulletins and/or social media pages.

The Missions Office thanks all who are helping to sustain the needs of our archdiocese as we all experience the effects of this pandemic--spiritually, mentally, physically and financially. May we draw ever deeper into communion with our brothers and sisters in Christ around the world, who

are also bearing these hardships. As Pope Francis said in his moment of prayer before the "Urbi et Orbi" Blessing, "We cannot go on thinking of ourselves, but only together can we do this."
