QuickBooks Update

Due to the new Federal Form 1099-NEC, we will be performing a QuickBooks update beginning this evening, Friday, **December 18.** QuickBooks will be unavailable tonight, **Friday, December 18 at 7:00 pm through Sunday, December 20.** We will let you know as soon as the update is completed. We apologize for any inconvenience this may cause.



SLAF Holiday Hours

On Thursday, December 24, all ACH transactions must be received into ACH@archstl.org or SLAF@archstl.org mailboxes by 10am for processing on the 24th.

Between Christmas and New Year's, the SLAF staff will be in the office from 10am to 2pm daily and any ACH transactions for those days must be received by noon, otherwise it will wait until the next day for processing.

Curia Offices Closed

Update Christmas Mass and Reconciliation Times in PHOL

To ensure the faithful have the most up-to-date information please update your parish's Christmas Masses and Reconciliation times in Parish Helper OnLine, if your parish has not done so already. This will enable the archdiocesan website to display these schedules for each parish. Detailed instructions begin on page 6 of the User Manual which is located under the Help Menu in PHOL. The Start Date drop down menu lists the various Masses.

Contribution Statement Policy

The Archdiocesan policy regarding the distribution of annual donor statements is as follows: Parishes using ServantPC Cloud may place an announcement in their bulletin or mail postcards when the statements are ready for donors to download. Donors may also contact the parish office and request that a statement be mailed.

If the parish is not using Servant PC Cloud, the policy regarding emailing statements remains the same as in prior years: All statements should be mailed to donors (not emailed or placed in the back of church for pickup). If a donor notifies you that they have not received the mailed statement and requests a copy be emailed, you may do so. Annual Contribution Statements must be mailed or made available by January 31, 2021.

Servant Keeper Statement Training

Servant Keeper will be offering detailed Contribution Statement training for **free** if you are a Servant Keeper Help Desk subscriber. Previous attendees have described the webinar is as very helpful. There are two remaining training dates available January 7 and January 19. There is a \$49 fee for non-subscribers. Parishes are required to send contribution statements to all those who have given \$250 or more during the calendar year.

2020 Yearend Tax Forms

Parishes that converted to Lawson payroll after January 1, 2020 and those still running payroll in QuickBooks are reminded to issue W2s to their employee for the time payroll was run in QuickBooks. We anticipate delivery/installation of the 2020 W-2, and W-3. forms January 10, 2021. We understand this is much later than usual. Be assured we will notify you as soon as QuickBooks releases the necessary forms. Before running your employee W-2's, we ask that you submit your completed W-3 to Parish Support for approval. Please remember the 4th Quarter 941/Sch B cannot be reviewed or approved without the completed W-3. Employees must receive their W-2 no later than Federal deadline of January 31, 2021.



Parish Support will again complete the 4th Quarter 941 for those parishes that chose not to receive a PPP loan or for those issuing COVID Sick or Leave pay through QuickBooks. You should have received the quarterly 941 survey in early December. Please complete it and return as soon as possible after completing the final 2020 payroll run. From Internal Audit IRS Form 1099-NEC

Many parishes have prepared the IRS Form 1099-MISC to report nonemployee compensation. Beginning in January 2021, these payments for services will now be reported on a separate form, 1099-NEC. All parishes should carefully review the instructions to forms 1099-NEC and 1099-MISC to ensure compliance with the IRS regulations. Penalties for not filing correctly and providing all necessary information can be costly. As a best practice, parishes should receive a completed W-9 before any payments for services are made to a vendor as these forms help identify vendors that are 1099 eligible.
